### HMK® R170 - EXTERNAL STONE CLEANER

- **Special concentrated cleaner for removing general dirt, moss and vegetation from paths and patios.**
- **Fast working and effective treatment for all natural and artificial stone.**
  - **Suitable for polished surfaces.**
  - **For exterior use only.**

HMK® R170 is a special long lasting acid free concentrated cleaner that removes general dirt and eliminates and prevents the reformation of moss, mould and other vegetation from paths, patios, walls and steps made from natural and artificial stones and other forms of external paving. Even extremely dirty surfaces will become clean and bright again. HMK® R170 does not damage polished surfaces. For exterior use.

**Important:** Do not apply in direct sunlight. HMK® R170 causes discoloration on textiles. Protect plants and lawns against splashes. HMK® R170 should be used within 6 months.

**Instructions:** Dilute HMK® R170 with water 1:5 and spray thoroughly and evenly onto a dry surface using a watering can fitted with a rose or "T" bar. Leave the application overnight to work and rinse off the next day with fresh clean water using a scrubbing brush or broom. HMK® R170 can be used undiluted in the case of very strong contamination.

We recommend the application of an HMK®-Impregnator (e.g. HMK® S232 Stain Protection - water based or HMK® S234 Stain Protection - extra) to keep surfaces clean for longer.

**Coverage:** About 20-30m<sup>2</sup>/litre.

**Warning:** Chemical product. Contains surfactants, caustic solutions and auxiliary agents. Avoid eye/skin contact. If exposed, wash/flush with water and seek medical attention. At all times wear suitable protective clothing (gloves, masks, boots, etc...). Keep out of the reach of children. See Material Safety Data Sheet for more detailed information.

**Packaging:** 12 x 1 litre bottles/box; 2 x 5 litre cans/box.

**Storage:** Store in a cool dark place out of the reach of children.

**Testing:** Always test the product in an inconspicuous area to evaluate suitability, coverage and performance. Do not use the product in temperatures below 12° and above 25°C.
